



ORDER

The petitioner had challenged the order of dismissal passed by the third respondent, pursuant to the report filed by the internal complaints under the POSH Act, 2013.

2. I have considered the arguments advanced by the learned counsel on either side and perused the materials available on record.

3. From the facts that has been narrated by the respective parties, it could be seen that pursuant to the complaint dated 28.12.2024, from the student, complaining of Sexual Harassment against the petitioner, an



enquiry was contemplated on 31.12.2024 before the Internal Complaints

WEB COPY Committee and the petitioner had been terminated from service on 09.01.2025. An enquiry report had also been submitted by the I.C.C on the very same day, that is on 31.12.2024. A perusal of the enquiry report placed before this Court by the respondents would indicate that the petitioner had not been given an opportunity to cross examine the complainant or any other witnesses.

4. A perusal of the report would indicate that the Committee had not been constituted as per the parameters of the Act. There is no Chairman of the Committee nor there is no outsider as required under the Act. That apart, an enquiry had been conducted without following the principles of natural justice and as envisaged under the POSH Act and the enquiry report has also not been given to the petitioner. The impugned order had not been preceded with a show cause notice to the petitioner, calling upon his explanation. Therefore, this Court finds that there has been a flagrant violation of the provisions of the POSH Act and Rules framed thereunder.

5. For the aforesaid reasons, the impugned order is set aside with

WEB COPY liberty to the respondents to conduct an enquiry as per the provisions of

the POSH Act and thereafter, proceed with the disciplinary proceedings against the petitioner. No order as to costs. Consequently, connected Miscellaneous Petitions are closed.

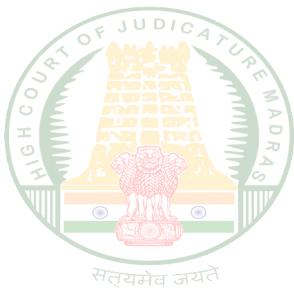


